For such arrangements, formaldehyde-based embalming is prohibited as is the use of metal or concrete grave-liners, burial-vaults, or other permanent burial containers. Caskets, coffins or alternative containers used to enclose and transport the dead are made of bio-degradable materials and are available in a range of prices. Home wakes, public visitations, church funerals and graveside services are options that may be arranged within the time frame green burial allows. We charge you for our services in buying certain items.

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

The direct cremation prices do not include the crematory charge.

“If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiber board or composition materials (with or without an outside covering). The container we provide is corrugated fiber board.”

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.”
